2019 was a productive year for your board and the many contributing volunteers.

- The pool was re-plastered and the pool decking was pressure washed and sealed. Also, the latch on the pool entry gate was moved higher so that small children cannot access it. A new chemical regiment was initiated, eliminating the need to annually shut down and drain the pool.
- The carpet in the clubhouse was removed and was replaced with tile.
- The volleyball court was completed and is ready for use. A berm was created to deflect flood waters from washing through the court and the dangerous concrete border around the court was removed.
- The playground was upgraded with new equipment.
- The area around the flag poles and butterfly garden was improved with slate rock.
- The roof of the storage building was repaired, as it had sustained wind damage.
- The A/C in the clubhouse was repaired.
- The toilets in the women's pool restroom were upgraded.
- Some security cameras have been upgraded.
